AN ORDINANCE REPEALING CHAPTER 2.28.07 (Ord. 2006-01) RELATIVE TO THE CITY OF BULL SHOALS POLICE OFFICER(S) REQUIRED TO LIVE WITHIN THE CORPORATE LIMITS OF THE CITY OF BULL SHOALS WITHIN SIXTY (60) DAYS FROM DATE OF HIRE.

WHEREAS, the City Council of Bull Shoals, Arkansas realizes to hire future and/or retained current fully certified police officers the restriction of a residence requirement may place a burden on the city in the hiring of qualified applicants.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BULL SHOALS, ARKANSAS:

SECTION 1. That present and future Bull Shoals City Police Officers will be required to live within twenty (20) road miles from the city limits of the city of Bull Shoals, Arkansas.

SECTION 2. New hires will be required to live within these boundaries within sixty (60) days from the date of hire, except for the Chief of Police, who must live within the corporate limits of the City of Bull Shoals.

SECTION 3. Realizing that Auxiliary Law Enforcement Officer(s) maybe the future full time officers of the city, they may live within Marion or Baxter County while in the Auxiliary status.

<u>SECTION 4.</u> Chapter 2.28.07 (Ord. 2006-01) of the Bull Shoals Municipal Code is hereby repealed. And, any other ordinance, resolution, policy, writing or parts thereof, which may be in direct conflict with this Ordinance, are also repealed.

<u>SECTION 5.</u> If any part of this Ordinance is declared invalid or unconstitutional for any reason, such declaration shall not be held to invalidate or impair the validity, force or effect of any other part of this Ordinance.

SECTION 6. Emergency Clause: This Ordinance being necessary to continue the operation of the City of Bull Shoals, Arkansas in compliance with the laws of the State of Arkansas and to preserve the public peace, safety and welfare, an emergency is hereby declared and this Ordinance shall be in full force and effect upon the date of its passage and approval.
